







# Timetable for notified bodies surveys

for the "Study supporting the monitoring of availability of medical devices on the EU market (HaDEA/2021/P3/03)"

Version: October 2024 (3.0)

In the context of the implementation of Regulation (EU) 2017/745 on medical devices and Regulation (EU) 2017/746 on in vitro diagnostic medical devices, the European Commission's Directorate-General for Health and Food Safety (DG SANTE) - via the European Health and Digital Executive Agency (HaDEA) - commissioned a **study supporting the monitoring of availability of medical devices on the EU market** to a consortium led by the Austrian National Public Health Institute (Gesundheit Österreich GmbH / GÖG), in collaboration with Areté and Civic Consulting.

For this purpose, the study team will collect information and data through **targeted surveys** with key stakeholders which play a crucial role in the availability of medical devices including notified bodies, manufacturers, and authorised representatives (in the case of non-EU manufacturers), as well as in a later stage health service providers and patient representatives. For surveying notified bodies **three different recurring surveys were developed** which alter in content, length, and frequency (small, medium, and large dataset).

**To assist notified bodies in planning**, this document lists all envisaged mailings and deadlines as well as the requested data set for the first, second and third study year.
