In the context of the implementation of Regulation (EU) 2017/745 on medical devices and Regulation (EU) 2017/746 on in vitro diagnostic medical devices, the European Commission's Directorate–General for Health and Food Safety (DG SANTE) – via the European Health and Digital Executive Agency (HaDEA) – commissioned a **study supporting the monitoring of availability of medical devices on the EU market** to a consortium led by the Austrian National Public Health Institute (Gesundheit Österreich GmbH / GÖG), in collaboration with Areté and Civic Consulting.

For this purpose, the study team will collect information and data through **targeted surveys with key stakeholders** which play a crucial role in the availability of medical devices including notified bodies, manufacturers, and authorised representatives (in the case of non-EU manufacturers), as well as in a later stage health service providers and patient representatives. For surveying notified bodies **three different recurring surveys were developed** which alter in content, length, and frequency (small, medium, and large dataset).

To assist notified bodies in planning, this document lists all envisaged mailings and deadlines as well as the requested data set for the first and second study year.
